





# **EDUCATIONAL OPPORTUNITIES**

Join in unique educational opportunities while in Little Rock.

#### WILLIAM J. CLINTON PRESIDENTIAL LIBRARY & MUSEUM

*What*: The Clinton President Library is offering self-guided tours of their facility. You will have access to an Apple or Android app and will be able to tour the facility. Volunteers will be on hand to answer any questions you may have. Team members (including non-competing team members) will be able to enter the museum for free. All others will be charged a discounted admission fee of \$10.

When: Wednesday, 9 am - 5 pm and Thursday, 9 am - 3 pm

Where: 1200 President Clinton Avenue

*How*: All visitors will travel to the Library on their own. The library is about a fifteen-minute walk directly east of the Little Rock Marriott.

#### LITTLE ROCK CENTRAL HIGH SCHOOL

*What:* Little Rock Central High School is a National Historic Site commemorating the fight for school based integration and equality through the stories of the Little Rock Nine. "In 1957, Little Rock Central High School was the epicenter of confrontation and a catalyst for change as the fundamental test for the United States to enforce African American civil rights following Brown v. Board of Education." - https://www.nps.gov/chsc The National Parks Service has a museum commemorating the history of Little Rock Central High School itself. (Visits inside of the school will not be allowed, as this is a normal school day.)

When: Wednesday, 9 am – 3 pm and Thursday, 9 am – 3 pm

Where: 2120 W. Daisy L. Gatson Bates Drive

*How*: Visitors may use prearranged busses (please check with Host staff to confirm) or travel on your own. Buses will be scheduled to depart 45 minutes after each hour from the Old Statehouse Museum (located next to the Little Rock Marriott). Teams may also choose to visit the museum on their own.

#### TRIAL LOCATIONS AND COURTHOUSE SECURITY

Please expect security at both Courthouses. At registration, every team will receive a box. It is recommended that each team use this box to place all items (belts, phones, keys, cameras) in the box before the security screening and then slide the box through security at the respective courthouses. Then all participants and observers should proceed through security. Generally, courthouse treat security like the airport—if it cannot go through security at the airport, it cannot come into the courthouse. Water bottles, with lids, are permitted through security. We have been given special permission to bring in cell phones; however, *taking pictures inside the building using a cell phone is prohibited*.

Please give yourself and your teams ample time to enter security in advance of your trials. Please be courteous to the staff and ensure you pick up after selves. Please share your appreciation for their use of their space.


